

## Surrogate Compensation Sheet

### Gestational Carrier Fees

(Gestational Carrier fees are held in an escrow account)

Baseline compensation for a 1 <sup>st</sup> time surrogate: paid in equal monthly installments after ultrasound confirmation of pregnancy, all states. This includes payment for a positive pregnancy test and payment for heartbeat confirmation.	\$40,000
Baseline compensation for an experienced surrogate: paid in equal monthly installments after ultrasound confirmation of pregnancy, all states. This includes payment for a positive pregnancy test and payment for heartbeat confirmation.	\$45,000
Medication Start	\$500
Embryo transfer	\$1000
Monthly stipend for miscellaneous expenses: \$300/month, estimated 14 months	\$4,200
Maternity clothing allowance (singleton / multiples)	\$600 / \$800
<b>Gestational Carrier Fee Total:</b>	<b>\$46,300 - \$51,500 estimated</b>



## Supplemental Wellness and Family Benefits Package

The Gestational Carrier shall be entitled to receive a variety of supplemental family benefits such as: date nights, family movie and/or dinner nights, adventure day tickets, entertainment, and/or wellness packages (i.e. pregnancy massages, acupuncture, chiropractor, doula, et al) and “special dates” gifts (i.e. birthdays, holidays, etc.). Gestational Carrier will receive benefits in this entire amount but not more. Intended Parent(s), at any time throughout the journey, may use funds from this benefit package to have All Families Surrogacy send specific requested gifts on their behalf.

Supplemental Wellness and Family Benefits Package: \$2,000

## Variable Expenses

**All Families Surrogacy requires a \$20,000 Variable Expenses Deposit into escrow for variable expenses, due upon execution of your Surrogacy Contract.**

This deposit is fully refundable approximately three to five months after the conclusion of your surrogacy journey, minus any required variable expenses paid out.

Gestational Carrier’s Lost Wages for surrogacy related appointments	Varies
Hotel and Meals for Transfer Bedrest	Varies
<b>Counseling for Gestational Carrier</b>	<b>\$1,200</b>
Multiple pregnancy – per additional fetus	\$5,000



Dropped or Mock Cycle- Starts medication but is unable to complete transfer	\$500
Cesarean Birth	\$3,000
Invasive procedure compensation - per occurrence (D&C, CVS, cerclage, etc.)	\$1000
Physician ordered bed rest and/or postpartum period: Lost Wages, Housekeeping, Childcare	Varies
Partner's lost wages	Varies
Gestational Carrier's travel expenses	Varies
Breast milk - \$350 per week, plus supplies & shipping	Varies
Fetal reduction	\$1000
Ectopic pregnancy surgery	\$1,000
Termination after 13 <sup>th</sup> week or labor induction due to no heartbeat or abnormalities	\$2,000
Loss of ovaries or fallopian tubes (per each)	\$1,000



Loss of uterus / hysterectomy	\$5,000
Birth Doula and/or Postpartum Doula	\$1000- \$2000
Chiropractic, Massage, Alternative Medicine	\$800-\$1,000
Pet Boarding	\$25-50/day

Note- All of these are subject to negotiation by the surrogate and the intended parents.
